## Sub: Plea for holding 12<sup>th</sup> examination in physical mode.

taken all the needed precautions of ideally spacing the examinees six feet apart in every exam centre already fixed by it, by doubling their number, with strict instructions to sanitize the sitting spaces making wearing masks a dead compulsion.

The Board can further request the respective state governments to arrange the screening of the examinvigilating staff to ward off the possible threat of infection. With the sitting spaces and writing material fully sanitized, examinees ideally spaced and invigilators duly screened the examination centre has become fully safe to hold the examination.
